



# TERMS AND CONDITIONS

1. All persons ('the entrants') entering the Bacardi Spiced Game Day competition, agree that the competition rules as set out in these terms and conditions are binding on them.

## 2. Important notice:

2.1 These terms and conditions and competition rules contain certain terms and conditions which appear in similar text style to this clause and which:

- May limit the risk or liability of the promoter or a third party; and/or
- May create risk or liability for the entrant; and/or
- May compel the entrant to indemnify the promoter or a third party; and/or
- Serves as an acknowledgement, by the entrant, of a fact;
- The entrant cannot be a juristic entity and must be an individual.

2.2 The entrant's attention is drawn to these terms and conditions because they are important and should be carefully noted.

2.3 Nothing in these terms and conditions is intended to, or must be understood to, unlawfully restrict, limit or avoid any rights or obligations, as the case may be, created for either the entrant or the promoter in terms of the South African Consumer Protection Act, 68 of 2008 ("the CPA").

2.4 The entrant acknowledges that by submitting his/her entry to the competition he/she has been given an appropriate opportunity to first read these terms and conditions before entering and that he/she understands and agrees to the terms and conditions.

2.5 All entrants participate in this competition entirely at their own risk. By reading and accepting these terms and conditions, the entrant gives consent to these risks and hereby indemnifies and holds harmless the promoters Bacardi-Martini Inc, their directors, employees and agents of any and all liability pertaining to any damage, cost, injuries and losses of whatever nature sustained as a result of their participation in the competition and related events and activities, save where such damage, cost, injuries and losses are sustained as a result of the gross negligence or willful misconduct of any indemnified party.

2.6 Applicable Liquor Laws apply.

3. The competition is valid from 1 May 2023 – 30 September 2023. Entries close at midnight on 30 September 2023. No late entries will be considered.

4. The competition is open to :

4.1 Any director, member, partner, employee, or agent of, or consultant to Bacardi-Martini Inc who are the promoters of the competition, or any other companies forming part of the Bacardi-Martini Inc group of companies.

4.2 Any suppliers, service providers, or contractors of Bacardi-Martini Inc, being a supplier of goods or services in connection to the competition.

4.3 Any spouse, partner, sibling, parent, or child of any of the above.

5. Participants can enter the competition via the three following channels: Pick n Pay Liquor in-store, Pick n Pay ASAP & on-consumption activations.



## 5.1 Entry mechanics for participants are as follows:

### Varsity Vibe & Pick n Pay Liquor in-store:

- Generate a wiCode on the Varsity Vibe app or website.
- Buy a 750 ML bottle of Bacardi Spiced at Pick n Pay Liquor.
- Present the wiCode to a staff member at the till in Pick n Pay Liquor.
- Receive a 10% discount from the purchased 750 ML bottle of Bacardi Spiced.
- The Varsity Vibe 10% discount is valid from 1 - 29 May 2023, which can only be redeemed at selected in-store Pick N Pay Liquors.

### Pick n Pay ASAP:

- Buy a 750 ML bottle of Bacardi Spiced.
- Stand a chance to win a foosball table.
- The foosball table competition is valid from 1 May 2023 - 19 June 2023.

### Pick n Pay in-store:

- Buy a 750 ML bottle of Bacardi Spiced.
- Swipe your smart shopper card and stand a chance to win a foosball table or a table tennis table.
- The foosball table competition is valid from 1 May 2023 - 19 June 2023
- The table tennis table competition is valid from 1 August 2023 - 16 September 2023.

### Activations:

- Buy a 750 ML bottle of Bacardi Spiced and mixer, and receive a token.
- Show your token to the Bacardi activators, and be entered into a game.
- Challenge a friend, and stand a chance to win merchandise (t-shirts, moonbags, glassware, bucket hats and ping pong sets).
- The activation competition is valid from 1 May 2023 - 30 September 2023

## 6. Prizes

6.1 To be eligible to win the prizes, entrants must be natural persons residing in South Africa, be in possession of a valid ID and be 18+ years of age.

6.2 Pick n Pay instore and Pick n Pay ASAP winners will be notified by Pick n Pay.

6.3 Activation winners will be notified and given prizes immediately after the game matches on location.

6.4 The prizes are not exchangeable or can be redeemed as a monetary value.

### 7. General:

7.1 If a potential winner cannot be contacted after three attempts are made within 3 (three) days of the draw, and/or the potential winner does not produce the documentation required to claim their prize, within 3 (three) days of being notified that they are a potential winner, or such longer period to which Bacardi-Martini Inc may agree, then the potential winner will forfeit their prize and another potential winner will be randomly drawn to replace them.
